# MEETING MINUTES Monday, October 17, 2016

#### I. CALL TO ORDER

Chairman Steingart called to order the special meeting of The Sullivan County Infrastructure Local Development Corporation at approximately 11:45 AM, in the Legislative Committee Room at the Sullivan County Government Center, Monticello, New York.

While waiting for a quorum to assemble, Attorney Garigliano informed the Board that the **Adelaar** project will buy water from the Village of Monticello through the newly formed Adelaar Water District. The Village has an adequate water supply for the Adelaar project but lacks adequate water storage capacity. As the owner of the structures and infrastructure that comprise the Adelaar Water District, TSCILDC has been asked to contract with the Village of Monticello for the construction of a new three million gallon water storage tank. This increased water supply is necessary for the development of the water park at Adelaar, which is currently moving through the State Environmental Quality Review (SEQR) process. Attorney Garigliano continued that he will prepare draft water storage agreement and a resolution authorizing the execution of the water storage agreement, so that the new tank can be constructed. He asked the Board to consider recessing this meeting and reconvening on November 2, 2016 to consider the resolution and agreement.
